When carotene-containing foods are eaten in large quantities, beta-carotene and other carotenoids can be absorbed and transferred to various tissues in large enough quantities to impart an orange or yellow color to serum ("hypercarotenemia") and skin. Because beta-carotene has the potential to be converted into vitamin A, it is theoretically possible that high levels of carotene intake could produce elevated levels of Vitamin A. However, high carotene intake is not associated with Vitamin A toxicity. Inhalation: Inhalation of large amounts may cause mild respiratory tract irritation. Respiratory tract irritation is a low hazard for usual industrial handling. Chronic Potential Health effects: no information found.
